Voting hours will be from 11:30 a.m. to 1:30 p.m. and from 4:45 p.m. to 5:30 p.m.

This election will be held for the purpose of determining whether the aforesaid employees want to be represented by: PUBLIC EMPLOYEES ASSOCIATION OF KANSAS (PEAK) or have NO REPRESENTATION.


We will need assistance from the employer and employee organization on the date of the election to provide identification of each eligible employee voting so that their names can be checked off the eligible employee voters list.

Board rule 84-2-12 allows for observers. The Board allows the public employer one observer and the employee organization one observer at the polls.

All parties are required to meet at 11:00 a.m. at the polling area on the day of the election, in order for the Board Agent to instruct observers on election procedure.

Enclosed are NOTICE OF ELECTION sheets, sample BALLOT forms and an INSTRUCTION TO ELECTION OBSERVERS sheet. You are hereby ordered to post the NOTICE OF ELECTION sheets and sample BALLOT forms in places conspicuous to all employees.

O R D E R

The above entitled matter came before the Board on September 30, 1974 for determination of the appropriate unit. The Board finds that on August 27, 1974 Public Employees Association of Kansas filed a petition purporting to be for unit determination and certification of an employee organization. Further by order of this Board, on August 28, 1974 the public employer had until September 9, 1974 to object to said petition or allegations of said petition would be deemed admitted. The Board finds that no objections were filed, that the employer submitted a letter in agreement to the appropriateness of the unit, which was received by the Board on September 24, 1974. The time in which to file any objections has expired, and the unit herein should be set forth as petitioned.


