All managerial, confidential, supervisory and other employees not specifically included above.

It has been brought to the attention of the Public Employee Relations Board that the positions of Corrections Sergeant Records Clerk, Dispatchers, Technicians, Secretaries, Parking Control, Cook and Custodian are not "uniform police employees", as required by K.S.A. 1995 Supp. 75-4327(f).

K.S.A. 1995 Supp. 75-4327 (f) states in part:

"A recognized employee organization shall not include... (2) uniform police employees and public property security guards with any other public employees, but such employees may form their own separate homogenous units;..."

Since the established bargaining unit is contrary to Kansas law, the following positions are hereby removed:

Corrections Sergeant Records Clerk
Dispatchers
Technicians
Secretaries
Parking Control
Cook
Custodian

THEREFORE, the Board finds that the bargaining unit for the Riley County Police Department, case number 75-UDC-4-1996, shall henceforth be composed of the following classifications:


