DECERTIFICATION OF REPRESENTATIVE

Pursuant to the provisions of K.S.A. 75-4327 (d), a decertification election was conducted on March 22, 1979. The results of that election were as follows:

APPROPRIATE UNIT INVOLVED: Public Works Department and Power Plant Employees

INCLUDE: All street, water, park, sewage, sanitation and custodial employees and foreman employed by the City of Russell, Kansas Public Works Department and Electric Power Plant Employees

EXCLUDE: All uniform fire and police, all secretaries, professional, elected officials, supervisors, and cemetery sexton, and all electric department employees except those employed in the power plant.


Approximate number of eligible voters	30
Votes cast for existing organization (Service Employees Union 513)	7
Votes cast for opposing organization (N/A)	0
Votes cast for "NO REPRESENTATION"	23

Based upon the election results it is our determination that there has been no representative designated for the above mentioned appropriate unit. Therefore, Service Employees Union Local 513 is hereby officially decertified.

Further, IT IS ORDERED that the above named public employer shall no longer be required to meet and confer with Service Employees Union Local 513



I will be contacting all parties for a convenient date for the election in the near future. If you have any questions do not hesitate to call this office.




Dear Mr. Boyd:

Please let this letter serve as your official notification of the election results from the recent decertification election in the City of Russell, Public Works Department, our case number UDE 3-1979.

The time limit for filing objections to the election having past, the results of the election are certified in the following manner. Thirty votes were cast. Seven votes were cast for Service Employees Union Local 513. Twenty-three votes were cast for "No Representation". The majority of votes cast were cast for "No Representation" and, therefore, the results of the election did not carry in favor of Service Employees Union Local 513.
