ORDER TO UPDATE STATEWIDE APPROPRIATE UNITS

Comes now on the 27th day of July, 1976, the above-captioned case for hearing. The hearing was conducted before Jerry Powell, duly appointed hearing examiner for the Public Employee Relations Board. The case comes before the board on petition by the Department of Administration, State Division of Personnel, State of Kansas. The petition calls for the placement of newly created job classifications in previously established appropriate units and the removal of job classifications which have been abolished by the State Finance Council.

The hearing was conducted July 27, 1976. Appearing on behalf of the State Department of Administration was Mr. Darrell Hoffman and Mr. Larry Morlan. There was no opposition to the petition as presented.

It is, therefore, the order of the board that the following job classifications be placed in the existing units as listed:


The following job classifications have been abolished and are, therefore, removed from all appropriate units.
