

Social Worker (MSW)


**STIPULATION #3.**

**The only employees who shall be eligible to be included within either the Shawnee County Health Agency Support Staff Unit or the Professional Staff Unit shall be those individuals who are employed directly by the Shawnee County Health Agency. No other employees of Shawnee County, or any other employer, regardless of their classification, shall be eligible to be included within the Shawnee County Health Agency Support Staff Unit or the Professional Staff Unit unless they are directly employed by the Shawnee County Health Agency.**

**WHEREFORE the undersigned Parties request that PERB accept the above and fore-going as the stipulations of the Parties and issue a order amending the respective bargaining units.**
