ORDER

Comes now this 18th day of January, 1989, the
above captioned matter for consideration by the Public Employee
Relations Board.

Pursuant to the mutual agreement of the parties, and the
Board finding no illegality in the proposed action, hereby finds
and orders the following:

- 1) That within the 1974 statewide unit determination order (SUD-1-1974) six geographical units of non-professional social services field employees were determined to be appropriate,
- 2) That the six distinct supervisory areas which corresponded to the above mentioned geographical parameters of the units no longer exist within the Department of Social and Rehabilitation Services,
- 3) That the parties to this matter agree that the intent of the act would be best accomplished by a combination of the six (6) above referenced geographical units into one comprehensive statewide unit,
- 4) That many job titles and classifications have changed since adoption of the 1974 statewide order, and
- 5) That the appropriate unit in the above captioned matter should be comprised in the following manner;




