## UNIT DETERMINATION ORDER

NOW, on the 7th day of August, 1997, the above-captioned petition for Unit Determination and Certification came on for review. Pursuant to the mutual agreement of the parties, that the following classifications be placed in the Leavenworth County Emergency Medical Service Unit, and there being no statutory violation found in the proposed action, it is determined that the appropriate unit shall be comprised of the following classifications:

**INCLUDE:** All full-time employees of Leavenworth County Emergency Medical Service, including EMTs, Paramedics, Team Leaders and Shift Supervisors.

**EXCLUDE:** The employee assigned to the wheelchair van and all administrative and/or office staff (i.e., clericals and other full-time employees who regularly work five days per week, eight hours per day).



**RIGHT TO REQUEST HEARING**


