Pursuant to the mutual agreement of the parties that the following classifications should be placed in a Support Services Unit for Geary County Government and there being no statutory violation found in the proposed action, it is determined that the appropriate unit shall be comprised of the following classifications:

INCLUDE: Cartographer, Clerk I, Clerk II, Cook, Crew Foreman, Data Collector, Data Entry Clerk, Emergency Preparedness Secretary, Food Service Manager, Landfill Equipment Operator, Legal Secretary, Legal Secretary Bookkeeper, Motor Vehicle Clerk, Personal Property Appraiser, Rural Appraiser, Review Appraiser, Records Clerk, Rural Patrol Operator, Secretary/Bookkeeper, Shop Assistant, Shop Foreman, Tax Clerk, Truck Driver, Victim/Witness Coordinator, Warrant Clerk, Waste Water Operator/Sign Technician, and Weed Sprayer Operator.

EXCLUDE: Administrative Assistant, Deputy County Clerk, Deputy County Treasurer, Deputy Register of Deeds, Motor Vehicle Supervisor, Noxious Weed Supervisor, and all other classifications not specifically included above.


