
**UNIT DETERMINATION ORDER**

NOW, on this 24<sup>th</sup> day of July, 2003, the above-captioned matter comes on for consideration by the Public Employee Relations Board (PERB). Pursuant to agreement, the parties, the International Association of Fire Fighters, the Kansas Department of Administration, the Office of the State Fire Marshal, and PERB, finding no statutory violation in the establishment of the proposed unit, hereby orders that the appropriate unit for the Fire Prevention Inspection employees within the Office of the State Fire Marshal be established as follows:

**INCLUDE:** All full-time and part-time employees in regular positions in the Fire Prevention Inspector classification.

**EXCLUDE:** The Fire Marshal, Assistant Fire Marshal, Chief Deputy Fire Marshal, Inspection Division Chief, supervisory employees and all other employees.


