at 10th and Vine, Hays, Kansas, for the purpose of determining  
whether the aforesaid employees want to be represented by the  
following employee organization: SERVICE EMPLOYEES UNION LOCAL  
513, AFL-CIO.

We will need assistance from the employer and employees on  
the date of the election to provide identification of each eligible  
employee voting so that their names can be checked off the eligible  
employee voters list.



Public Employee Relations Board rule 84-2-12 allows for observers. The Board allows the public employer one observer and the public employees one observer at the polls. All parties are required to be at the polling area by 3:00 p.m. on the date of the election in order for the Board Agent to instruct the observers on election procedure.

Enclosed are NOTICE OF ELECTION sheets, sample BALLOT forms, and an INSTRUCTION TO ELECTION OBSERVERS sheet. The public employer is hereby ordered to post the NOTICE OF ELECTION sheets and sample BALLOT forms in places conspicuous to all employees.

O R D E R

The above entitled matter came before the Board on February 21, 1974 for determination of the appropriate unit. The Board finds that on January 30, 1974 the Service Employees Union Local 513, AFL-CIO filed a petition purporting to be for unit determination and certification of certain Service & Maintenance employees of Hays, Kansas. The Board further finds that no objections have been filed, that the time in which to file such objections has expired, and that the unit herein should be determined as set forth in the petition.

It is therefore ordered that the appropriate unit in this matter before this Board concerning certain Service & Maintenance employees of the City of Hays, Kansas shall be as follows:

INCLUDE: All employees in the Water Department, Sewage Disposal, Service Department, Foreman I and all other non-supervisory employees

EXCLUDE: All Security, Elected Officials, Confidential Secretaries, Secretaries and Supervisory Personnel as defined in the Act.



Inasmuch as the unit has been determined as set forth above, we request a list (names and addresses) of all eligible employees of the appropriate unit who were employed on the date the petition was filed, January 30, 1974. This is in accordance with PERB rule 84-2-11(a)(3) and (4).

Please review rule 84-2-11 regarding voter eligibility. Note rule 84-2-11(4) which states, "At least seven days prior to the election, the employer shall furnish to each employee organization which is a party to the proceeding, a list of the names and addresses of the employees in the appropriate unit who were on the payroll on the date of the filing of the petition and who are on the payroll at the time of the submission of the list."
