ASSOCIATION OF KANSAS (PEAK) FOR UNIT DETERMINATION & CERTIFICATION  
OF CERTAIN SECRETARIAL AND OFFICE EMPLOYEES AT KANSAS STATE COLLEGE  
OF PITTSBURG

O R D E R

The above entitled matter came before the Public Employee Relations Board on October 18, 1973 for determination of the appropriate unit. The Board finds that on July 18, 1973 PEAK filed a petition purporting to be for Unit Determination & Certification of an employee organization. Further by order of this Board, on July 20, 1973, the public employer (Kansas State College of Pittsburg) had until July 27, 1973 to object to said petition or allegations of said petition would be deemed admitted. On July 25, 1973 both the employer and State Division of Personnel filed objections to the petition. On July 30, 1973 the Board requested certain information from PEAK to complete information needed in filing petitions and on August 3, 1973 answers were received from PEAK. The Board finds that a hearing was held on September 20, 1973, during which the parties came to an agreement on the positions in the proposed unit. An agreement to the unit involved was made in writing on October 12, 1973, signed by both the employer and employee organization representative. The Board further finds that the unit herein should be determined as set forth in the petition and agreement.

It is therefore ordered that the appropriate unit in this matter before this Board concerning certain employees of the Kansas State College of Pittsburg shall be as follows:


