



IN THE MATTER OF CASE UE 5-1973 - PETITION OF KANSAS PUBLIC EMPLOYEES UNION COUNCIL 64, AFSCME, AFL-CIO FOR UNIT DETERMINATION AND CERTIFICATION OF CERTAIN EMPLOYEES OF THE CITY OF TOPEKA DEPARTMENTS OF STREETS, WATER POLLUTION CONTROL AND SANITATION

O R D E R

The above entitled matter came before the Board on October 18, 1973 for determination of the appropriate unit. The Board finds that on September 24, 1973 Kansas Public Employees Union Council 64, AFSCME, AFL-CIO filed a petition purporting to be for Unit Determination and Certification of an employee organization. Further by order of this Board, on September 27, 1973 public employer (City of Topeka) had until October 5, 1973 to object to said petition or allegations of said petition would be deemed admitted. The Board finds that on October 3, 1973 the public employer requested extension of time to file answer to said petition, and on October 4, 1973 the Board granted public employer until October 17, 1973 to file answer. The Board further finds that an amended petition was received from Council 64 on October 8 and an agreement to the amended petition received from the public employer on October 10, 1973.

It is therefore ordered that the appropriate unit in this matter before this Board concerning certain employees of the City of Topeka Departments of Streets, Water Pollution Control and Sanitation shall be as follows:


