Pursuant to the mutual agreement of the parties and the Director of Labor Relations finding no statutory violations in the proposed action, it is hereby determined that the appropriate unit in the above-captioned matter shall be comprised of the following classifications:

**INCLUDE:** All full-time Instructors  
Part-time Instructors who teach eight (8) or more hours per semester during the day on the main campus with regular office hours and/or committee assignments, who have taught a minimum of (6) consecutive semesters with a minimum of eight (8) hours at Cloud County Community College  
Assistant Director of the Learning Skills Center  
Librarian  
Career Counselor/Advisor  
Sponsor and Instructor - Radio Broadcasting and Student Publication

**EXCLUDE:** All Athletic Coaches who do not qualify as instructors under the negotiated agreement and all Part-Time Instructors other than those described above.
