**ORDER**

ON, the 5th day of January, 1993, an election was held to determine whether the employees in the professional classifications of Licensed Mental Health Technician Specialist and Activity Therapist I should be included in the non-professional unit at the Rainbow Mental Health Center pursuant to order in 75-UCA-6-1990 and in accordance with K.S.A. 75-4327 (f) (1).

By a vote of 0 Yes and 1 No the employee in the classification of Licensed Mental Health Technician Specialist voted not to be included in the non-professional unit.

By a vote of 3 Yes and 0 No the employees in the classification of Activity Therapist I voted to be included in the non-professional unit.

IT IS THEREFORE ORDERED that the non-professional unit at the Rainbow Mental Health Center shall be amended to include the


