**ORDER TO AMEND**

Now, on this 31<sup>st</sup> day of **December, 2008** the above-captioned matter came on for consideration before the Executive Director for the Public Employee Relations Board.

This petition for Unit Clarification or Amendment submitted by the Kansas Organization of State Employees (KOSE) has the effect of modifying the Maintenance, Trades and Technical unit #1 and the Administrative Professional unit #5 of the state's realigned units as ordered by the Public Employee Relations Board (PERB) in case No. **75-UD-1-2007**. Specifically, the petitioner seeks to remove the position classification of Correctional Industry Manager from the Administrative Professional unit and place those positions into the Maintenance, Trades and Technical unit. The petition also seeks to add the position classification of Facilities Maintenance Supervisor to the Maintenance, Trades and Technical unit, because incumbents in this classification assigned to

correctional facilities primarily supervise inmates and do not supervise state employees in regular positions.

Pursuant to the mutual agreement of the parties, KOSE, D of A and KDOC and there being no statutory violations in the proposed amendment, it is hereby ordered that the classifications of Correctional Industry Manager and Facilities Maintenance Supervisor positions assigned to correctional facilities be placed into the Maintenance, Trades and Technical unit. The amendment of the Administrative Professional unit will be addressed in a separate order.

As determined appropriate by the PERB in case No. 75-UD-1-2007, the unit parameters for the Maintenance, Trades and Technical unit, are as follows.

**INCLUDE:** Employees included in this unit shall be in classified and/or unclassified job titles and in full-time or part-time regular positions with similar or like job classifications or functions.


**EXCLUDE:** Employees excluded from this unit shall be all confidential, managerial, supervisory, temporary and original appointment probationary status employees, elected officials and positions in Regents Institutions.

Positions specified by class title, job code, agency and classified or unclassified position status that are found to be appropriate to this unit are attached hereto and made a part hereof.




