ORDER

ON, the 7th day of January, 1993, the above-captioned petition for Unit Clarification and Amendment came on for review by the presiding officer. Pursuant to written stipulation (attached hereto) and mutual agreement of the parties, Teamsters Local Union 696 and Shawnee County, the existing Shawnee County Public Works Department employee unit established in 75-UDE-3-1992 should be amended to include the position of **Civil Engineer Technician**.

The presiding officer finds the amended unit to be appropriate, no statutory violation in the proposed action, and that the proposed unit should be adopted.

IT IS THEREFORE ORDERED that the unit shall consist of the following classifications:


