**DETERMINATION OF APPROPRIATE BARGAINING UNIT, CERTIFICATION OF
REPRESENTATIVE AND ORDER TO MEET AND CONFER**

A bargaining unit, described below, having been determined by agreement of the parties, and it being deemed appropriate under applicable state law by the Board; and

A "card check" having been conducted in the above matter by the Public Employee Relations Board in accordance with the Public Employer-Employee Relations Act and the Rules of Procedure of the Board, and it appearing that an employee organization has been selected by a majority of unit employees;

Pursuant to the authority vested in the Board by the Public Employer-Employee Relations Act,

**IT IS HEREBY CERTIFIED THAT Teamsters Local Union 696 and Teamsters
Local Union 795**

has been designated and selected by a majority of the employees of the above named public employer. As their exclusive representative, they will meet with the employer for the purpose of meeting and conferring with respect to grievances and conditions of employment. The appropriate unit for the Juvenile Corrections unit at the four (4) agency locations (Atchison, Beloit, Larned and Topeka) shall consist of the following classifications:

INCLUDE: Juvenile Corrections Officers I and
Juvenile Corrections Specialists.

EXCLUDE: All other Juvenile Justice Authority
classifications and temporary
positions not specifically included
above.

Further, **IT IS ORDERED** that the above named public employer shall meet and confer with

Teamsters Local Union 696 and Teamsters Local Union 795

and may enter into a written agreement with such employee organization with regard to conditions of employment, and shall meet and confer with such organization in the determination and administration of grievances.


