
**UNIT DETERMINATION ORDER**

ON this 26th day of April, 1993, the above-captioned petition for unit determination and certification came on for review. Pursuant to the mutual agreement of the parties that the following classifications should be placed in a Clerical Unit for Unified School District 500, Kansas City, Kansas, and there being no statutory violation found in the proposed action, it is determined that the appropriate unit shall be comprised of the following classification:

**INCLUDE:** All secretaries employed by the Board of Education of Unified School District No. 500, Wyandotte County, Kansas, and placed on the secretaries' salary schedule.

**EXCLUDE:** Secretary for the Superintendent of Schools; Secretary for the Assistant Superintendent for Personnel; Secretary for the Assistant Superintendent for Business Affairs; Secretary for the Director of Special Education; and Secretary serving in the capacity of Clerk of the Board of Education.

**NOTICE OF RIGHT TO REVIEW**


