
**WHEREFORE, THE BOARD ORDERS**, pursuant to and consistent with the Stipulation for Decertification/Certification filed by the parties that the American Federation of State, County and Municipal Employees and Local No. 1294 of Missouri/Kansas State Council No. 72 be decertified as exclusive collective bargaining representative for the employees classified as Groundskeeper, at the Sunflower Hills Public Golf Course and that the exclusive bargaining representative, as set forth in K.S.A. 75-4321, *et. seq.*, shall be the Public Service



**STIPULATION FOR CERTIFICATION AND  
DECERTIFICATION OF CERTAIN EMPLOYEES**

COMES NOW, Public Service Employees Union, Local No. 1132, AFL-CIO (hereafter "Local 1132"), American Federation of State, County and Municipal Employees and Local No. 1294 of Missouri/Kansas State Council No. 72 (hereafter "AFSME"), and the Unified Government of Wyandotte County/Kansas City, Kansas ("Unified Government") and stipulate as follows:

- (1) AFSME is currently the exclusive bargaining representative for those employees classified as Groundskeeper, employed by the Unified Government, at the Sunflower Hills Public Golf Course (hereafter "Sunflower Hills").
- (2) The Groundskeeper employees currently working at Sunflower Hills wish to be represented by Local 1132. Copies of duly executed authorization cards from all four of the individuals employed as Groundskeeper at the Public Golf Course are attached hereto

and incorporated herein by reference. Local 1132, is willing to represent the employees working as Groundskeeper at the Public Golf Course.

- (3) AFSME disclaims any further interest in representing employees classified as Groundskeeper, employed at the Public Golf Course and does not oppose Local 1132's assuming the representation of these individuals.
- (4) Local 1132 and AFSME hereby stipulate that AFSME shall be decertified as the exclusive bargaining representative for the Groundskeeper employees at Sunflower Hills and that Local 1132 shall be certified as the exclusive collective bargaining representative for the Groundskeeper employees at Sunflower Hills.
- (5) The Unified Government is in agreement with this decertification and certification of exclusive collective bargaining representative for the Groundskeeper employees at Sunflower Hills.
- (6) Accordingly, Local 1132, AFSME and the Unified Government respectfully request that the Public Employer/Employee Relations Board enter an order effectuating this stipulation for decertification and certification as set forth herein.


